

中国中铁是集勘察设计、施工安装、工业制造、房地产 开发及其他业务于一体的特大型企业集团,是目前全球 最大的建筑工程承包商之一,在世界企业500强中排 名第137位,在中国企业500强中排名第9位。公司 于2007年12月3日、12月7日分别在上海、香港两 地上市。公司总资产3893亿元,净资产738.9亿元。

中国中铁建设者先后修建了72228公里的铁路,占全 国铁路总里程的三分之二以上;建成电气化铁路接触网 46047 公里,占全国电气化铁路的 95%;参与建设的 公路超过12656公里,其中高速公路超过6960公里, 约占全国高速公路总里程的十分之一;参与建设了全国 五分之三的城市轨道工程:修建了武汉长江大桥、南 京长江大桥、东海大桥、杭州湾跨海特大桥等 9000 多 座大桥,总长达7621公里;建成秦岭隧道、太行山隧 道、厦门翔安海底隧道、武汉长江隧道等长大隧道共计 5576公里。公司建设者九次远征南极,承担了我国中 山站、长城站、昆仑站建设和维护任务。公司还先后参 加了国内4000余项公路、机场、码头、水电、地铁、 高层建筑、市政等大型工程的设计与施工,经营范围覆 盖到土木建筑的各个领域,工程项目遍布全国各省市自 治区和全球 60 多个国家和地区,科技水平在诸多领域 达到世界先进水平,多次获得国家最高奖项。

General Situation of Company

CREC is the extremely large enterprise group with survey and design, construction and installation, industrial manufacturing, real estate development and other business. At present, it is one of the largest construction contractors in the world, ranking 137th in the top 500 companies in the world and 9th in the top 500 Chinese enterprises. Companies were listed respectively on December 3rd, 2007 and December 7th,2007 in Shanghai and Hong Kong, with the total assets of RMB 389.3 billion Yuan and net assets of RMB 73.89 billion Yuan.

CREC have built railways of 72228 kilometers, more than two-thirds of the total length of national railway; the electrified railway contacting net they have built reaches 46047 kilometers, accounting for 95% of national electrified railway; they are participated in the road covering over 12656 kilometers, of which expressway is more than 6960 kilometers, about one-tenth of high mileage: they are participated in the three-fifths of national urban rail project: they have constructed more than 9,000 bridges, including Wuhan Yangtze River Bridge, Nanjing Yangtze River Bridge, the East Sea Bridge, Hangzhou Bay Cross-sea Bridge, with the total length of 7621 kilometers; they have built long tunnels of Oinling Tunnel, Taihang tunnel, Xiamen Xiang'an undersea tunnel, Wuhan Yangtze River Tunnel and so on, with the total of 5576 kilometers. The builders with the Antarctic expedition for 9 times shouldered the construction and maintenance tasks of Zhongshan Station, Great Wall Station and Kunlun station. The company also has participated in more than 4000 items of national highways, airports, docks, hydropower, subway, high-rise buildings, municipal and other large engineering design and construction, with the business scope covering all civil construction fields, and the projects in all provinces and autonomous regions of the nation and more than 60 countries and regions in the world. The technological level in many areas has reached the world's advanced level, and has won the national highest award for many times.



业务分布

2010年,中国中铁认真贯彻国家调结构、扩内需、惠民生的重大方针政策,全力扩大市场份额,积极调整经营结构,生产经营 在持续高位运行的基础上,又迈上了一个新的台阶,新签合同额和完成营业收入都有大幅提升。2010年公司完成营业收 入4736.6亿元,实现海外营业收入237.8亿元。

2010年,公司在全球近60个国家和地区开展业务。目前,境外在建工程项目312个,涉及铁路、公路、桥梁、隧道、房屋建筑、城市轨道、市政工程、农田水利、港口建设等领域,分布于南美、东欧、非洲、南太、东南亚、中东等51个国家和地区。公司的道岔及钢结构等产品远销到美国、韩国、新西兰、加拿大、丹麦等16个国家和地区。

另外,公司在境外投资兴办了药厂、纺织厂,并加大了房地产开发、资源开发等业务量。

Business Distribution

In 2010, CREC has strictly implemented the national major guidelines and policies of adjusting structures, expanding domestic demand and improving people's livelihood, worked hard to enlarge its market shares, and actively adjusted the operating structure. The production and operation went up to a new step on the base of constant high–level operation, and both the new–signed contracts and achieved operating revenue were enhanced on large scale. In 2010, the company completed the business income of RMB 473.66 billion Yuan, and overseas revenue of 23.78 billion Yuan.

In 2010, the company started business in nearly 60 countries and territories. At present, 312 overseas construction projects have been involved in railways, highways, bridges, tunnels, housing construction, urban rail, municipal engineering, water conservancy, port construction and other fields in 51 countries and areas of South America, Eastern Europe, Africa, South–Pacific, Southeast Asia, the Middle East. Company's products of turnouts, the steels and others are exported to 16 countries and regions of the United States, South Korea, New Zealand, Canada, Denmark and others.

In addition, the company overseas invests and sets up pharmaceutical factories and textile mills, and also increases the business volume of real estate and resource development and so on.

治理结构

Company Governance and Standardized Operation

Structure Governance

In 2010, we further optimized the management models conformed to the listed companies, improved the internal controlling management system: under which the board, supervision, and managers were closely linked with each other, and the company management structure operated effectively; the normalization and effectiveness of the broad operating was further intensified; the management system and salary management system were further improved; and the company management level and transparency were further enhanced. In 2010, the company won the awards of "Best Board", "Chinese Top Hundred Listed Company"; "2010 Best Company Management" and others.

By the end of the report, the company board was consisted of 7 members, 4 of which were independent directors; there are five special committees under the board; the auditing committees, salary and evaluation committees were consisted of independent directors; the supervision was consisted by 5 members, 4 of which were workers' representative directors; the upper management was consisted of one president, 7 vice president, one general economists and one board secretary.

2010年,中国中铁高度重视决策管理,秉承"规范、高效、透明" 的管理理念,从机构设立、程序管理等各个方面切实提高公司 的决策水平,严格依据《公司章程》、《股东大会议事规则》、《董 事会议事规则》、《监事会议事规则》、《总裁工作规则》以及董 事会各专门委员会的议事规则等公司治理规则的规定,开展经 营管理决策工作,有效确保股东大会、董事会、监事会、经理 层谨慎决策和规范运作,切实维护了公司股东和债权人的合法 权益、不断完善和规范公司的组织和行为,有力推进公司业务 良好开展和稳定运行。

Decision-making Management

In 2010, CREC paid great attention to decision-making management, adhering to the management philosophy of "standard, efficiency and transparence", and effectively improved the company's decision-making level from the institutions establishment, process management and other aspects. Strictly in accordance with Memorandum of Association, Procedure Rules of Shareholders, Procedure Rules of Boards, Procedure Rules of Board of Supervisors, the Working Rules of President as well as various special committees of the Board procedure rules and other rules of corporate governance, the company carried on decision-making management to effectively ensure that the general meeting, board of directors, board of supervisors and managers make decision carefully and carry on standard operation, and earnestly safeguarded the company's legitimate rights and interests of shareholders and creditors, continuously improved and standardized the company's organization and conduct business, and effectively promoted good conduct and stable operation.

内控监督

中国中铁对内控体系建设高度重视,2010年,中国中 铁董事会及其审计委员会加强了对内控工作的指导,监 事会也加大了对公司内控的监督。公司专门成立了内控 体系建设领导小组,明确内控主责部门,在各单位全面 开展了内控体系建设,总部和先期试点的7家单位内控 体系正式启动运行。加强投融资集中管控,严格集团授 信、大额度资金使用和对外担保,强化金融衍生业务监 管,加强经济合同、规章制度和重要决策的法律审核把 关,加大内部经济纠纷调解力度,有效控制了企业的经 营风险,销售费用率、管理费用率、财务费用率等指标 持续好转。积极开展工程项目审计、经济效益审计、内 控制度评审和专项审计调查,促进增收节支3458万元。

2010年,公司在各级企业开展全面风险管理工作。从公司和业务流程两个层面,评估识别了公司层面重大和重要风险,把公司重大、重要风险与业务管理流程以及总部的管理制度进行了全面对接,识别关键控制点590余个,建立和更新风险库、风险事件库,优化了风险解决方案,完善了风险控制措施,确保公司层面重大和重要风险在业务流程执行中得到有效控制。

2010 年,公司认真贯彻中央"四个文件"精神,全面 落实党风廉政建设责任制和国有企业领导人员廉洁从业 若干规定,加强对"三重一大"集体决策制度执行情况、 领导干部廉洁从业及薪酬管理情况的监督,加大对资产 流失责任追究、工程项目违纪违法案件查处的力度。把 工程建设领域突出问题专项治理,作为促进企业管理、 加强党风廉政建设的着力点,对全公司工程项目进行了 全面排查,对246个工程项目进行了重点检查,提出整 改意见110条;先后组织新任职领导干部集体廉洁谈话 10场、612人次,组织开展警示教育261场、6563人次。

Internal Control Monitoring

CREC pays high attention to the inner control system. In 2010, the company board of directors and its audit committee strengthen the guidance on internal control, and supervisory board also increase the supervision on internal control of the company. The company has set up a construction and leading group of inner control system to clearly control the primary responsibility department. All units of CREC have conducted the construction of inner controlling system, and the inner controlling systems of 7 units in the head quarters and the early experimental units. CREC has intensified the management and control of the investment and financing, strictly controlled the group credit, the usage of greatamount funds and external Guarantee; intensified the supervision of financial derivative business and the inspection on the legal verification of economical contracts, regulations and rules; enlarged the strength of mediating inner economical disputes and effectively controlled the operation risks of the enterprise. Indicators like sales cost, management costs, financial cost and others were constantly improving. CREC also actively conducted the project auditing, economical profit auditing, the evaluation of the inner controlling system and inspection of special auditing, to promote the income and saved 34.58 million yuan.

In 2010, all departments of the company have carried out wholeaspect risk management, which assessed and recognized the significant and gigantic risks of the company level from two aspects of company and business process, have comprehensively docked the gigantic and significant risks of the company, the business management process and the management system of the head quarter, identified more than 590 crucial controlling points, built and renewed the risk pool, the risk event pool, optimized the risk solutions, improved the risk-controlling system, thus ensured the effective control of the gigantic and significant risks in the business process operation at the company level.

In 2010, the company seriously carried out the spirit of "Four Documents", fully implemented certain provisions about the Clean and Honest Administration and integrity employment of state-owned enterprises leaders, strengthened supervisions of the implementation of the collective decision-making system "three-important and one-big", leading officials' clean employment and salary management, intensified investigation and prosecution for accountability on the assets, cases of projects violating discipline and law. The company has specially treated the outstanding problems in the project construction aspect. As the point of focus for the enterprise management, and intensification of cultivation of party conduct and construction of a clean government, the company comprehensively inspected all projects of the company, especially inspected 246 projects and put forwards to 110 suggestions on modification; the company successively organized 10 collective talks on clean government of 612 newly absorbed leaders; organized 261 alarming education for 6563 people.

Outstanding Contribution

Since 2008, we took the lead to disclose the value of a share of social contributions of the company in the industry.

In 2010, we continued to improve the assessment system, researched and estimated the value of corporate social contribution value and one share value of the CREC in 2010 with the combination methods of self-statistics, estimation and expert assessments, just for your reference.

Our formula:

Corporate social contribution value = profit contribution + tax contribution + debt interest contribution+ employee contribution + the public welfare contribution + other contributions – negative contribution to the environment – negative contribution to the safety and quality – other negative contributions.

Each share of social contribution value = corporate social contribution value / total equity

In 2010, the track laying (the new line, double line) that the whole company has completed covered 7901 kilometers, the electrified railway contacting net was 10203 kilometers, the roads covered 1591 kilometers (including the expressway of 1126 kilometers), the new-constructed bridge covered 1946 kilometers and the tunnel extended 869 kilometers, further improving transportation infrastructure and living environment.



In 2010, the company total revenues was RMB 473.66 billion Yuan, up 36.52 %; the amount of new–signed contracts reached RMB 735.48 billion Yuan, up 22.2%; the total amount of total Taxes & Profits was RMB 28.08 billion Yuan, up 23.2%, net profit was RMB 7.488 billion Yuan, on average each share made profits of RMB 0.35 Yuan. 引领产业进步

In the field of recent year's national basic constructions, especially the construction of high-speed railway, the company has broken through series of technical challenges and owned a whole set of techniques and standard system in exploring, designing and construction through bringing-in and independent innovation, reached the world advanced level, and made up the blank in many fields both domestic and abroad.

At present, the company is one of the first "innovative enterprises" in China awarded by the Ministry of Science and Technology, the State Council and the ACFTU, has owned the "National Project Laboratory of High Speed Railway Construction Techniques", the "National Key Laboratory of Shield and Tunneling Technology" and 4 postdoctoral workstations. The company has owned 4 national certificated enterprise technical centers and 15 interprovincial certificated enterprise technical centers, successively formed 6 professional research and developing centers for bridge, tunnel, electrification, advanced project materials and the inspecting techniques, runway and construction equipments.


In many fields of high-speed railway construction technology, plateau railway construction technology, extremely large, complex and cross-sea bridge building technology, the under-sea (rivers) and the complex environment of the tunnel and urban subway construction technology and others, the company has reached the world advanced level.

In 2010, the company has taken part in the formation works of 10 national standards, and won 125 Provincial floor–processing methods. Up to now, the company has 103 state–level construction methods, 794 provincial construction methods and 2,188 enterprise–class construction methods.

In 2010, the company organized and conducted the crucial technical and scientific researches on the passenger special line, high speed railway and other national key engineering construction, carried out researches on the theoretical foundation, designing standards, construction verification, complete equipments and other aspects, has overcome series of significant technical problems, further intensified the scientific and innovative ability of the enterprise. The whole company has 1180 new scientific projects with a total investment of more than 8 billion yuan. Improvement of the Management System

CREC is constantly taking "to maintain stable condition of safe production, to provide the society with safe and good-quality architectural products, provide the public with pleasant environment and create safe and health working condition for the staff" as the most important aspect of social responsibility for the enterprise. In the long-term construction production and project management process, CREC formed a complete set of perfect safety management system, including the safe production responsibility system, prevention of major accidents, safety input, safety education, safety management and safety inspection, safety assessment, rewards and punishments and so on, and also formed a more mature safety management concept and safety policies, principles and safety management objectives.

CREC Security Concept: hidden dangers in the fire, prevention is better than disaster relief, and responsibility is extremely heavy.

Safety management policies: safety first, prevention as main and comprehensive management.

Safety management principles: unified leadership, responsibility, classification management and guidance, full participation.

Safety management objectives: building of intrinsic safe enterprise.

In 2010, the company has constantly improved the supervision management network and management system, strictly implemented and conducted the "Safe Production Year" activities, the requirement of the "Central Enterprise safe production supervision and management Interim Measures", the safe production "Three Action" and "Three Construction", the daily safe production management, the combination of mass safety supervisors and "Safe Production Month", gradually fulfilled the safety production responsibility system of "one post, double duties, each responsibility to one post". The safety production awareness of the whole staff has been greatly enhanced; the environment protection and occupational health are developing harmonious; the quality creation work has achieved excellent results and the project quality and safety production situation are ordered and controllable.

资料2:2010年,中铁九局与沈阳铁路局合作,组织了 15期营业线施工安全培训,共培训专职安全员、专职 质量员、驻站联络员、防护员3000多人;中铁十局2至 7月份开展了为期五个月共三个阶段的隧道工程质量安 全专项整治活动;由中铁咨询负责监理的北京地铁大兴 线01标段获得"全国建筑施工安全质量标准化示范工 地称号"。

Implementation of Safeguard Measures

In 2010, CREC has taken the implementation of safeguard measures as crucial point for safety management, constantly increased the safety production investment, innovated the safety production and inspection working model, conducted all-round severe inspection on safety production, signed the safety quality responsibility book level by level, increased the accountability of accidents, implemented safety production one-vote negation system, actively conducted quality safety special activities, deeply promoted the safety supervision work of the first-line mass, established the safety responsibility area and safety supervising position in the while company. The company has strictly implemented the regulations, tightly controlled the process, refined the safety management into every type, procedure and link of the work, making the safety production of the company were controlled, and the safety production conditions were mainly stable.

In 2010, the company modified and republished the "Safety Quality Accident Accountability Measures" and other safety production rules and regulations, to ensure the compliance of the enterprise rules and regulations. The company has issued the "Information about Further Intensification of the Safety Production Work", which includes 8 chapters and 28 sections, from the general requirement, to improve the eight aspects of safety production responsibility system of "one post, double duties, each responsibility to one post", safety monitors on construction projects, technical safeguard system, production safety supervision management, safety emergency rescue system, target evaluation and accountability system and enterprise safety culture, which raised requirements for the safety production of the company for a long time in the future, thus having great instruction meaning.

Information 1: For a long time, the company and its subsidiary enterprises have constantly insisted on signing safety production responsibility books level by level fro each project, through the quantification of indicators to decompose the responsibility, and implement the responsibility, purpose and mission of safety production into the leader of each department, thus effectively implementing the safety production responsibility system of "one post, double duties, each responsibility to one post". On safety production working conference of the while company on March 3 2010, President Li Changjin respectively signed the "Safety Production Responsibility Book" with the legal representative of each subsidiary company, the general manager of each subsidiary company, and of the commanders of the direct headquarters, totally 34 people.

Information 2: In 2010, CREC No. 9 Bureau has cooperated with Shenyang Railway Bureau, organized 15 phases of operating line construction safety training, and totally trained more than 3000 people including professional safety personnel, professional quality personnel, stationed liaison men and firemen; CREC No. 10 Bureau has carried out a 5-month-long special activities on tunnel project quality safety which included three phases from February to July; the Beijing Subway Daxing Line 01 Section supervised by CREC Consulting Group has won the honor of "National Construction Safety Quality Standardized Model Site ".

Increase of Safety Education

In 2010, CREC has increased the investment on safety education, broadly carried out kinds of safety educational activities, propagandized the safety production education through media and means like newspaper, websites, billboards, cable TV, DVD delivering and others. At 9:00 am, June 1 2010, more than 200 people of the headquarters, as well as the manger department of more than 6000 projects of the whole company, about 280 thousand employees and 1.8 million labors were carrying out the safety quality swearing activity; and the safety awareness of the whole staff has been further enhanced. More than 1 million people of the whole company have taken part in the "National Safety Emergency Knowledge Competition" held by National security production monitoring Deputy, the national emergency rescue center and the national federation of trade union, further enhanced the broad employees' realization of safety production emergency work.

Information 1: The company communist youth league deeply conducted "Safety Production, Youth First" speech competition, and safety itinerant speech activities for crucial projects, organized first–line youth staff to watch speech competition videos. The whole company has held 280 safety production speech competition, in which 3104 first–line staff have participated, with 14670 audiences; delivered more than 7 thousand speech competition videos, and trained more than 150 thousand employees.

Information 2: In June 2010, based on conduction of safety quality sworn activities, the company has normally carried out "Shift-before Safety Quality Pledge" activities on all important projects, construction sites, workshops and other first-line areas, set up unified safety quality pledge board on sites, organized the team (operating group) head to give speech first to encourage the whole staff to collectively make the safety and quality pledge in front of the safety quality board everyday before entering into the operating sites at the starting or hand-over time.

In the engineering field, the company continued to enlarge fund investment, improve staff's working conditions, and constantly improve the site dustproof, denoise and safety facilities, enhance the inspection and treatment of all noxious gas, dust, noise in the workshop, provide the personnel with working protection facilities and personal protecting materials to meet the safety and sanitation standards, minimize the occupational hazards maximized, and actively create a safe, clean, comfortable and harmonious working environment for the staff.

中国中铁始终秉承节约能源、减少排放的宗旨,把建立 资源节约型企业作为目标,把节约能源物资作为降低成 本、提高效益的重要手段。2010年,公司严格贯彻执行 能源管理体系(GB/T2331-2009)标准要求,推行能源 合同管理和节能减排标准化工地建设,加强能源消耗的 过程管理和控制,实现管理节能;加大经费投入,开展 节能减排技术攻关和技术改造,淘汰落后技术、设备, 实现技术节能,能耗水平不断下降,万元营业收入综合 能消耗水平位居中央建筑企业前列。2010年全面完成国 务院国资委下达的年度节能减排考核指标,获首届低碳 中国年度创新"领军品牌奖"和"首届全国低碳经济示 范单位"。

资料 1:中铁一局映汶高速公路 A2 合同段项目部自主研制高压储水罐供水装置替代高山水池供应施工和生活用水,节约建筑材料、减少供水管路长度、减少征地及施工对环境的破坏,与传统高山水池相比,具有结构简单、稳定性好、经济效益高等特点。到目前为止,该装置的使用已节约成本 128 万元。

资料2:中铁五局西安至铜川高速公路改扩建项目 XTK-1标段从制度管理上着手,规范定额领料制度、加 强现场管理,严格施工生产过程控制,节约钢材298吨; 节约水泥75吨;节约用油(柴油)10.4吨;节约商品 混凝土2986立方米,节约用电11455度。

资料3:中铁六局津秦客运专线平谷轨道板厂通过对轨 道板振动电机、滚轮运输等设备采取了变频方法调节电 机速度,同时满足负载要求,设备在电压电流都不改变时, 节电量与用电量成正比,实现节电率15%。

资料4:中铁隧道集团北京站至北京西站地下铁路直径 线项目,开展"降低混凝土损耗率新方法的探索"研究, 实现了混凝土损耗率由传统工艺的49.2%降低至新工艺的0.6%。

Thrift of Energy Material

CREC has been constantly insisting on the principles of energy-saving and emission-reducing, setting the establishment of energy-saving enterprise as the target, treating the saving of energy and materials as the main means to reduce cost and enhance profits. In 2010, the company strictly implemented the standardized requirements of the energy management system (GB/T2331-2009), promoted the construction of energy contract management and energy-saving and emissionreducing standardized base, to intensify the management and control of the energy consumption process, and fulfill the management of energysaving; increased the cost investment to conduct technical researches and reformation of energy-saving and emission-reducing, to eliminate the backward techniques and equipments, to fulfill the technical energysaving, and the energy consumption of the company has been constantly decreasing, and the comprehensive energy consumption per the operating profits of ten thousand yuan was among the top ones in the central architecture enterprises. In 2010, the company completely fulfilled the annual energy-saving and emission-reducing indicator delivered by the State Council, won the "Leading Brand Award" and "First National Low-carbon Economic Model Unit" of the first China annual low-carbon innovation.

Information 1: The project department of CREC No. 1 Bureau Yingwen Highway A2 Contract Section conducted independent researches on using high-pressure tank water supply to replace the water supply for construction and life water in hilly areas, to save the construction materials, reduce length g water supply tub, reduce the land acquisition and the damage of construction environment, which compared with the hilly water tanks, has characteristics of simple structure, good stability and high economical efficiency. So far, the use of such equipment had saved a cost of 1.28 million yuan.

Information 2: CREC No. 5 Bureau Xi'an–Tongchuan Highway Reconstruction Project XTK–1 Section has been started from the system management, to normalize the amount–fixed materials drawing, to intensify the site management of materials, strictly control the construction procedure, and saved 298 tons steel materials; 75 tons cements materials; 10.4 tons oil (diesel oil); commercial concrete 2986 cubic meters, and 11455 degree electricity.

Information 3: CREC No. 6 Bureau Tianjin–Qinhuangdao Passenger Special Line Pinggu Rail Track Board Factory has adopted the converting method to adjust speed of the electric machines through track board vibrating electric machines, trolley transporting equipments, also met the carrier requirement. The saved power is in proportion to the used power when there is no voltage or current change, saving power with the rate of 15%.

Information 4: CREC Tunnel Group Beijing Station–Beijing West Station Underground Railway Diameter Project conducted the research of "Exploration to New Method Decrease Concrete Loss Ratio", and achieved that the concrete loss ratio has been decreased from 49.2% to 0.6% of the traditional techniques.

资料3:中铁二局成绵乐铁路工程指挥部第二项目部用 水采用三级沉淀、循环使用,施工及生活污水集中处理 率达到50%以上,建筑污水再生利用率达到90%以上。

资料4:中铁隧道集团北京地下直径线项目自行研制开 发的泥浆固化系统,对不能循环利用的泥水进行固化, 再统一装车外运送至指定弃碴场,实现了泥水零排放, 开创了泥水盾构城市施工先例。

Reduction of Pollution Discharge

In 2010, the company all items actively promote standardization worksite construction, energy saving and emission reduction popularization and application of new technology, new techniques and new equipment, enhancing the efficiency of energy utilization and strict control of pollutants, increase the technical renovation and backward equipment dynamics, reduce exhaust emissions of liquid, making full use of slag etc waste. By 2010 the whole company no environmental liability accident and major energy conservation and emissions reduction violate compasses disciplinary event, discharges pollutants have all reached national and local corresponding emissions standards, the whole company industrial wastewater and waste gas and solid waste (waste) integrated control rate of 95%, "Three wastes" emissions success rate and fixed boiler emissions success rate is more than 80%.

Information 1: CREC construction engineering branch Dan tong expressway project, the use of dynamic design to improve the construction plan and use tunnel hole ballastleas and mining waste for subgrade filling, ballastless accounted for as little as possible, which greatly saving land use of farmland.

Information 2: CREC No. 2 Bureau Wenjia Stirring Station actively conducted the technical researches, developed the automatic treating system to reuse of concrete sandstone waste, solved the technical problems in treatment of waste water, Waste pulp and waste residue, achieved a recycling rate of 100% of the waste residue; the treatment and usage of solid waste has reached 100%, and totally achieved the "zero emission".

Information 3: CREC No. 2 Bureau Chengdu–Mianyang Railway Headquarter II Project has adopted Level 3 precipitation, to reuse materials, the treatment ratio of construction and life waste water has reached 50%, and the recycling usage of construction waste water has reached 90%.

Information 4: CREC Tunnel Group Beijing Underground Diameter Project independently developed the mud–hardening system, to harden the mud which is not recycled, and carried the mud to fixed spoil disposal area, achieved zero emission of mud, and became the precedent for the muddy water shield city construction.

资料2:2010年,中国中铁哈大指挥部严格执行 ISO14001:2004环境管理体系,采取施工现场修建沉淀 池和气浮池、集中设置改良土拌合场、对隧道施工弃碴 回收利用、安装空气污染控制系统等措施,保护了沿线 水源及水产品养殖池不受污染,做到少破坏或不破坏地 表植被,实现了绿色哈大的建设目标。

资料3:公司施工的深圳固成污水处理厂工程,成为 2008年鲁班奖项目中唯一的污水处理厂项目,2010年 3月15日,按照《深圳市创国家优质工程奖励试行办 法》规定,深圳市人民政府将价值3亿元的"观澜河干 流污染治理工程",作为该办法颁布以来的第一个大 奖,奖励给中国中铁施工。

Persistence on Environment Governance

On environment governance, CREC established a top-down, fully monitored green environmental protection management system to actively carry out protection work of ecologic environment. Each project department of the company insisted on "construction of excellent quality projects, creation of civilized ecology " principle, implemented high standards of environmental protection and soil conservation measures of the company and regarded "project quality and double excellence of environmental protection and water conservation " as its goal to strive to achieve the high degree of harmony and unity between excellent quality project and beautiful environment.

In 2010, the company actively participated in the project of constructing sewage treatment plant, air treatment, windbreak and sand-fixation, soil and water conservation, rivers and seas governance and so on. Then it became the main force of national environmental protection project field and made greater contribution to the global environmental protection continuously.

Information 1: On May 8 2010, the national environment protection department has conducted special inspection on the CREC No. 8 Bureau Beijing–Shanghai Project, checked the acquired land and local distribution of water of farm land, temporary site of the project department, and gage high assessment for the resume work of the countryside roads.

Information 2: In 2010, CREC Haerbin–Dalian Headquarter has strictly implemented the ISO14001:2004 environmental management system, adopted the measures to construct sedimentation basin and floatation tank on the construction site, to set up centralized improved soil regarding mix–proportion field, recycle the abandoned offscourings on the tunnel construction, to equip air pollution controlling system and others, to protect the water resources along the railway line, and the water products from pollution, to do less harm even no harm to the quality of land, and achieve the construction aim of green Haerbin–Dalian Railway.

Information 3: the Shenzhen Gushu Sewage Plant Project undertaken by the company, has been the only sewage plant in the 2008 Luban Award projects. On March 15 2010, according to regulations of "Shenzhen Creative National Quality Project Award Provisional Measures", Shenzhen People's government distributed the 300 million valued "Guanlan River Main Stream Pollution Treatment Project" to CREC, as the first great award since the implementation of the Measures.

Protection of Natural Ecology

CREC has always regarded the protection of the natural environment as a major task of building a harmonious society and the harmony between man and nature is reflected in the construction process of each project. Before starting every project, the company always organized experts to carefully carry out and construct project environmental influence assessment, to fully demonstrate the environmental protection programs and to develop a detailed program of ecological protection. In construction processes, the company imported environmental protection supervision, increased input of ecologic protection, perfected continuously green procurement system, used energy saving equipments, improved craft process method and studied and used new environmentally friendly materials and other issues to reduce the influence to water, air, vegetation, living creature and protect creature's diversity. No ecological destruction occurred throughout the year.

Information 1: In 2010, CREC No.2 Design Institute took the "the rare and endangered wild animals and plants along the railway line are not influenced, the sightseeing resources and landscapes are not destroyed, rivers and water sources are not polluted and ecological environment is recovered" as general target for the ecological and environmental protection in the designing work of the newly undertaking Chengdu–Lanzhou Line, combined with Sichuan University, CAS Chengdu Biology Institute, and other units to conduct the researches works of "Technical Resume Plan for Plant Quality in Chengdu– Lanzhou Railway Panda Life–tunnel and Shelter" and "Technical Resume Plan for Plant Quality in Chengdu–Lanzhou Railway Ecological Fragile District " and other researches.

Information 2: CREC Real Estate Group "China Railway • Yidu International" Project, has gained great recognition in the "UN China–Africa BBS and Real Estate Global ecological Livable Community Selection Assembly" held in Kenya in 2010 according to its unique ecological environment, innovative architectural products design, sustainable developing community mode, achieved the highest honor of the world livable field–"Global Ecological International Community Outstanding Model".

劳动合同

严格执行国家《劳动法》、《劳动合同法》,规范 劳动用工、合同管理,促进劳资关系和谐稳定,全 公司劳动合同签订率100%。公司通过积极拓展经 营、加强就业培训及指导,努力帮助待岗员工上岗 就业,减少待岗人数,有效保障职工的就业权。

薪酬绩效

建立了职工工资正常增长和保障机制,稳步提高员 工收入水平。建立健全符合现代企业制度要求的薪 酬管理体系,努力提高劳动报酬在初次分配中的比 重。2010年全公司职工人均收入51472元,同比增 长18.6%。无拖欠职工工资的现象。

社会保险

严格执行国家及所在地政府社会保险的相关法规, 依法建立健全规范的员工社会保险管理体系,及时 足额为职工缴纳"五险一金",为职工办理了补充 养老保险,2010年20.7万人参加补充医疗保险。

民主权利

2010年,公司召开了一届一次职工代表大会,会上 共收到职工代表提案223条,8名职工代表进行了提 案发言。厂务公开工作继续深化,畅通民主参与、 民主管理、民主监督渠道,保障职工的知情权、参 与权、表达权、监督权,公司第二次荣获"全国厂 务公开民主管理工作先进单位"称号。

职工保障

2010年,认真落实"三不让"承诺,共使用专项资 金7469万元,帮扶困难员工、农民工3.3万余名。 "两节"期间,筹措送温暖资金6131万元,慰问职 工、离退休人员、一线员工和农民工15.7万余名。

职工休假

严格执行国家《员工带薪年休假条例》,因工作需要未能按时休假的员工,根据国家有关规定给予经济补偿。对在法定节假日、公休假日和延长工作时间加班的职工,按照国家法律规定支付加班工资。

Maintenance of Staff's Rights and Interests

CREC paid much attention to maintenance of staff's rights and interests and supported gender equality. Through the agreement and signature of labor contract according to law, it established a scientific system of salary management and maintained the legal rights and interests of staff; by providing a broad development platform and building good talent training mechanism, it promoted common development of enterprise and staff.

Labor Contract

The company strict implemented the national "Labor Law" and "Labor Contract Law", constantly perfected the management system of labor staff and standardized labor contract management. The signature rate of labor contract in the whole company reached 100%. The company works hard to help the unemployed to get position, and decrease the number of unemployed workers through active expansion of operation, and intensification of job training and instruction, to effectively ensure the employment right of the employees.

Performance Pay

The company established normal increasing and safeguard mechanism of the employees' salaries, stably increased the employees' income, established and improved salary management system conformed to the modern enterprise systems, tried effort to enhance the proportion of labor payment in the first distribution. In 2010, the average income of the whole staff of the company is 51472 yuan, up by 18.6%, without delaying employees' salaries.

Social Insurance

The company strictly implemented the related regulations of the nation and local government social insurance, established and improved formal staff social insurance management system according to related laws, paid "five risks one gold" for the staff timely, and the supplementary endowment insurance for the staff. There were 207 thousand people participating in the supplementary endowment insurance in 2010.

Democratic Rights

In 2010, the company further held the first session of the first staff's congress, has received 223 proposals of the staff representatives in the congress, and 8 staff representatives have made statements on the congress. The factory work was constantly deepened, with broader democratic participation, management, and supervision channel, to ensure staff's rights to know, participate, make speech and supervise. The company has won the honor of "Advanced Unit of National Factory Democratic Management Work" for the second time.

Indemnity for Staff

In 2010, the company actively promoted the "three prohibition" promise, used 74.69 million yuan special fund, helped more than 33 thousand staff and peasant–workers. The company made great efforts to carry out "2 festivals" warmth–sent activities, financing more than RMB 61.31 million Yuan and expressing solicitude to more than 157 thousand staff, retirees and migrant workers.

Annual Leave for Staff

The company strictly implemented the national "Ordinance for Employee's Annual Leave with Salary". For the employees who could not have holidays timely due to work reasons, the company gave economic compensation according related national regulations. For the staff who worked on statutory holidays, public holidays and delayed work time, the company paid overtime wage according to national regulations.

公司致力于营造良好的员工成长成才环境,不断创新选 人用人机制。2010年,在全公司范围内进行了第三次 公开招聘,161人报名参加,143人进入笔试,21人 成功竞聘公司所属15家二级企业高管岗位,促进了优 秀人才的脱颖而出。

2010年,公司针对建筑企业的发展需要,突出项目经 理人才的培养,在已经建立的经营管理人才、专业技术 人才、高技能人才等职业发展序列的基础上,专门设立 了项目经理人才的职业发展序列,制定下发了相应管理 办法,为项目经理的成长成才提供了良好平台。

公司高度重视人力资源培养开发,建立健全以能力建设 核心,以职业发展为方向的人才培养开发机制,大力实施"大规模培训人才、大幅度提高队伍素质"工程,通 过培训激发员工潜力,提升能力素质,促进员工成长。 2010年,全公司共培训各类人才 30余万人次。

目前,公司拥有高级专业技术职务人才超过12000人, 其中教授级高工813人、高级工程师9000多人。公司 拥有高层次技术专家665人,其中有4名中国工程院 院士、6名国家国家勘测设计大师、6名国家级突出贡 献专家、284名人员享受国务院政府特殊津贴,123名 省部级、股份公司级专家,63人获得詹天佑大奖。

Promotion of Staff's Growth

CREC strongly implemented the "Talent Enterprise" strategy, promoted the enterprise development through talents development, treated the talents as the first enterprise recourse, made effort to prior explore the talents resources, prior adjust the talents structure, prior ensure the talent investment and prior innovate the talents system.

The company worked hard to build good environment for staff development, constantly innovate the selecting and employing mechanism. In 2010, the company has conducted the third time public recruitment in the whole company, and 161 people took part on the recruitment, 143 people got chances for the writing tests, and 21 people successfully got the executive positions of 15 secondary enterprises, greatly promoting the emergence of talented people.

In 2010, the company focused on the cultivation of outstanding project management talents according to the need of architectural enterprises, on the base of established operating management talents, professional technical talents, high–skilled technical talents and other professional developing items, has specially set up the professional developing item for the project management talents, regulated and issued related management methods, provided good platform for the development of project managers.

The company highly emphasized the cultivation and exploration of the human resources, established and improved the talents training system, with the ability construction as core, the occupational development as the orientation, strongly implemented the "Large–scale talent training, and large–scale enhancement of team quality" Project, to stimulate the staff's potential through training, and enhance the ability and quality, thus promoting the staff development. In 2010, the company has totally trained more than 300 thousand talents.

At present, the company has owned more than 12 thousand high–grade professional technical talents, among which there are 813 senior professors, more than 9 thousand senior engineers. The company has owned 665 high–grade technical experts, among which there are 4 members of Chinese Academic Engineering, 6 national exploring and designing masters, 6 national experts with outstanding contribution, 284 experts enjoying special government allowances, 123 provincial or shareholding company experts, 63 people awarded the Zhan Tianyou Award.

Information 1: In 2010, 1962 people have passed the company professional skill assessment for technicians, among which 681 were for the senior technicians. The technicians and senior technicians of the company took a proportion of more than 9% in the skilled talents, achieved the central enterprises senior skilled talents cultivation target of the State Council ahead of time to 2020.

Information 2: Since the "Eleventh Five–Year Plan", 17 employees of the company have won the title of "National Model Worker"; 215 collectives have won titles of "National May Day Labor Award", "Worker Pioneer", "Central Enterprise Advanced Collective" and "Loco Pot Award"; 459 individuals won titles of "National May Day Labor Model", "Central Enterprise Labor Model" as well as the "Loco Pot Model".

中国中铁始终坚持维护广大农民工的合法权益,自2005 年推行农民工与职工"同学习、同劳动、同管理、同生活、 同报酬"的"五同"管理以来,受到社会各界的广泛赞 誉。公司对农民工全部开展岗前培训和安全教育;督促 劳务分包企业、劳务派遣公司与劳务人员全部签订劳动 合同;建立了农民工工资监督机制,采取直接发放或办 理工资卡的形式,确保农民工工资按时足额发放;落实 农民工意外伤害保险和工伤保险,定期组织农民工体检; 认真开展"三工"建设,不断改善农民工工作、生活环 境;在组织各类技能大赛、技术比武和评先评优时,将 农民工纳入其中,充分调动农民工的工作积极性和创造 性,涌现出了一批农民工先进典型。

资料:中铁电气化局农民工巨晓林同志自强不息,奋发 进取,23年来先后参加12条国家重点铁路工程建设, 研发革新43项工艺工法,他编写的《接触网施工经验 和方法》成为铁路电气化施工的教科书,创造直接经济 效益600多万元。2010年,他的先进事迹受到中央领 导同志的高度重视和充分肯定,称赞巨晓林是"农民工 楷模",要求大力宣传学习他的事迹。2010年6月,中 宣部、中组部、全国总工会、国务院国资委和国务院农 民工工作办公室等五部委组织中央各大新闻媒体,对巨 晓林同志的先进事迹进行了集中采访和宣传报道,巨晓 林先后在国务院国资委、北京市作了事迹报告,并成为 中央电视台《新闻联播》"时代先锋"片头人物,其先 进事迹在全国产生了强烈反响。

Implementation of "Five Same" Management

CREC has constantly insisted on maintenance of legal rights of broad migrant workers. Since the company advocated the "five same" management, which is that the migrant workers and employees study together, work together, manage together, live together, have same salaries in 2005, the company has been praised by all social fields broadly. The company comprehensively conducted training for jobs and safety education for migrant workers; supervised the construction enterprises of work subcontractors, labor dispatching companies to sign labor contracts with the labors; established supervision mechanism for the migrant workers; salaries, adopted modes of direct delivering and salary cards, to ensure that the migrant workers' salaries are delivered on time; paid the migrant workers personal accident insurance and industrial injury insurance, organized regular physical examination for the migrant workers: carefully conducted "three sites" constructions, to constantly improve the working and living environment of the migrant workers; get the migrant workers into each kind of skill competition and outstanding performance evaluation, fully motivate the working activity and creativity of the migrant workers, therefore lots of advanced migrant workers representatives were spewing out in every units of the company.

Information: The migrant workers Comrade Ju Xiaolin of CREC Electrification Bureau has successively taken part in constructions of 12 national crucial railways in 23 years with constant self-improvement and competitive spirits, has developed and innovated 43 technical methods. The "Experience and Method of OCS Construction" he compiled has become the teaching book in the railway electric construction, created direct economical profits of more than 6 million yuan. In 2010 his deeds has been highly emphasized and recognized by central leader comrades, who praised his as the "Migrant Worker Model", and appealed the whole society to learn from him. In June 2010, Five administrations of the Propaganda Department, Organization Department, All-China Federation of Trade Unions, State Council, and the Administration of the Rural Workers Office have organized all the new medias to interview and propagandize the story of Comrade Ju Xiaolin, who has successively made achievement reports in the State Council and Beijing, become the top character for the "Contemporary Pioneers" of the CCTV "News Broadcast".


Reinforcement of Three Projects Construction

In 2010, CREC has insisted on the "people first" management notion, continuously conducted the "three projects constructions" of site life, site culture and site sanitation, with a total fund investment of 296 million yuan in the "three projects constructions", has vigorously promoted the first–line management; the working and living standards of employees have been constantly increased, the site culture has been further enriched, and the core competition power of the enterprise has been constantly enhanced.

Information 1: In 2010, CREC No.4 Bureau has collected 5.64 million yuan and sent condolences to 20447 employees, 37443 migrant workers through "cool–sending" activity in summer days, and the whole bureau has invested 80.536 million yuan special fund for the "Three Projects Construction".

Information 2: In 2010, CREC Bridge Bureau intensified the capital investment on the "Three Projects Construction" along Yangtze River projects; 9 departments totally invested 44.46 million yuan for the "Three Projects Construction", among which 10.95 million yuan for the site cultural construction, 26.79 million yuan for the site life construction and 6.72 million yuan for the site sanitation construction.

Information 3: In 2010, CREC Electrification Bureau has constructed 50 "employee bookshops". The whole bureau has established 195 "employee bookshops" in the first line, with a total area of 2536 square meters, and total storage amounts of 195.8 thousand books.

2010年,公司及所属各单位先后参加了西南地区抗旱 救灾、青海玉树抗震救灾,以及多条铁路、公路抢险任 务,员工捐款累计2500多万元,承建的新北川中学和 捐建的中国中铁映秀幼儿园先后建成或交付使用。公司 在玉树灾后重建中承担120余个项目,在参建单位中 设计出图最快、项目开工最早、工程数量完成最多。截 至 2010 年底, 拉秀镇 1000 套农牧民住房紧急建设任 务已开工 315 栋, 主体封顶 5 栋, 受到青海省政府高 度评价。2010年,公司积极开展定点帮扶和社会公益 活动,内容涵盖捐资扶贫、技术扶持、环境整治等诸多 方面,公司及广大员工投入社会公益资金、物资、劳务 价值超过2亿元。

资料1:2010年,在青海玉树抗震救灾中,中铁隧道 集团青藏铁路关角隧道工程指挥部主动出击,迅速展开 抢险救援和灾后重建,被授予"全国抗震救灾英雄集体" 称号。

资料2:2010年,在西南地区抗旱救灾中,全公司各 级共青团组织募集捐款80余万元,组织送水志愿服务 队 96 次,为灾区捐建水窖、水井、蓄水池、饮水管道 47 处。

资料3:2010年,中铁一局定点帮扶陕西省汉阴县, 为麒麟村发展农家乐产业提供资金和技术扶持, 使每户 每月增收2000元以上;为麒麟小学和村部购置电脑3 台,打印机2台,学生词典100本;整治村容,美化环境, 购买了垃圾清运车;修建通组连户道路,购买水泥,硬 化路面。

Disaster Relief & Assistance for the Poor

For years, CREC has come out bodily, worked in the first line, and dared to challenge when facing series of serious natural damages, actively toke part in the rescue works; broadly participated in the charity affairs, donated both money and materials to help the poor, actively fulfilled the responsibility of central enterprise, and has been highly praised by both the government and public.

In 2010, the company and its subsidiary units have successively taken part in the drought disaster relief works in Southwest areas, the earthquake relief work in Yushu, Qinghai province, and rescue missions on many railways and highways. The staff has donated more than 25 million yuan, and the undertaking new Beichuan School and the Yingxiu Infants' school donated by CREC were successively completed and put into service. The company has undertaken more than 120 projects in the post-disaster reconstruction of Yushu, and designed the drawing fastest, completed the project earliest, with most projects numbers. By the end of 2010, 315 of the 1000 farmer and herdsman housing emergent constructions have started in Laxiu Town, five of which have been covered, so the company was highly praised by the Qinghai Province government. In 2010, the company has actively conducted stationed helping and social charity activities, which included donation of capital to help the poor, technical instruction, environmental treatment and other aspects, and the company and the staff have donated 200 million vuan of the social charity capital, materials and labor value.

Information 1: During the earthquake relief work in Yushu, Qinghai Province, the headquarter of CREC Tunnel Group Qinghai-Tibet Railway Guanjiao Tunnel Project actively came out, immediately carried out the emergency rescue work and the post-disaster reconstruction, was honored the title "National Earthquake Relief Work Hero Collective".

Information 2: In the draught relief rescue works on southwest areas in 2010, the whole company and youth community league organization have collected more than 800 thousand yuan, organized 96 times of water volunteer supply, and donated to build 47 cells, drills and reservoirs in the disaster area.

Information 3: In 2010, CREC No. 1 Bureau conducted stationed help for the Hanyin County, Shanxi Province, provided fund and technical support to Qilin Village for the development of good farm industry, and brought the increased income of more than 2 thousand yuan for every family per month; purchased 3 computers, 2 printers, 100 dictionaries for Qilin primary school and village branch; treated the village, beautified environment, purchased garbage cleaning trucks; repaired group-cross and family-linked roads, purchased cements to harden roads.

Promotion of Employment & Maintenance of Stability

In 2010, at the same time of accelerating own development, adjusting industrial structure, the company has also constantly created new positions for the society, on the base of providing the staff with positions, still provided long-term stable employment opportunities for 1.8 million migrant workers. Meanwhile the company also provided ten thousands of employment opportunities in the foreign areas of South Africa, Southeast Asia, Middle-east and Africa, played irreplaceable role in the promotion of employment and maintenance of social stability, as well as the response to economical crisis. At the same time, by accepting graduates from universities, specialized secondary schools and technical training schools and demobilized servicemen and importing talent through talent market and other forms, the company created and provided a large number of new positions for society. 长期以来,中国中铁坚持"奉献精品工程,造福东道国家"理念, 先后完成了一大批如阿联酋棕榈岛填海工程、孟加拉帕克西 大桥工程、马来西亚沙巴洲铁路改造工程、尼日利亚铁路改建、 南非水坝工程、援加纳公路改扩建工程、安哥拉罗安达省医 院工程、摩洛哥高速公路和铁路等重大国际工程项目。公司 在境外还建立了科中制药公司、马里纺织厂、"刚果(金)矿 产资源开发"公司等企业,参与南非房地产开发。公司境外 工程和项目大都关系到东道国民生大计,对提高当地交通运 输能力、改善民众生活条件、加速东道国与周边国家的经贸 往来以及促进当地经济发展具有重要意义。

2003 年以来,公司所属各单位在实施对外承包工程中,累计 境外纳税总额达 11.6 亿人民币,约合 1.7 亿美元,有力促进 了当地经济发展。

Responsibility of the Global and the Model of the Global

For years, CREC has constantly insisted on nation of "dedication of elite projects to serve the host countries", has successively achieved a great number of projects like A couplet chief Zongyu Island Reclaim Project, Bangladesh Parker West Bridge Project, Malaysia Sabah State Railway Reconstruction Project, Nigeria Railway Reconstruction, South Africa Dam Project, Signing Ghana Highway Reconstruction Project, Luanda, Angola Provincial Hospital Project, Morocco Highway and Railway Project and other major international engineering projects. The company has also established Scientific Chinese Medicine Company, Mali Textile Factory, "the Congo (Golden) Mineral Resources Exploitation Ltd" and other companies abroad, participated in the exploration of real estate in South Africa. The oversea projects of the company have close relationship with the host countries' economic livelihood, have significant meaning for the enhancement of local transportation, improvement of local people's livelihood, acceleration of the economical cooperation of the host countries with the nearby countries, as well as promoted the development of local economy.

Since 2003, all units of the company has paid 1,16 billion RMB foreign taxes (almost 170 million dollars) during the implementation of foreign contracted projects, vigorously promoted the development of local economy.

In 2010, the oversea projects of the company have employed 20689 people. At the early stage of the project, the Chinese engineers and technicians have also given training for jobs, and trained more than 1500 all kinds of skilled technical workers every year.

Information 1: The company insisted on the location of "Environmental Friendly Enterprise", planted more than 10 thousand trees in Africa, and treated 16 thousand hectares farmlands and more than 2 thousand water wells for The Republic of Mali. In recent years, the company has invested about 61.25 million RMB on the environment protection in the countries of the projects during the implementation of the foreign contracted projects.

Information 2: In countries like Tanzania, Guinea, Sierra Leone, CREC No. 7 Bureau has delivered more than a thousand sets of bags, books and writing materials freely to the local schools based on the reality of the local educational materials; donated the ten-thousand-square-meter site to the local government as school lands after the implementation of projects; CREC actively helped the local government to improve the sanitary conditions, donated more than 2 thousand Jotham shillings to support the education and program for women and children.

Information 3: In Angola, CREC No. 4 Bureau has specially solved the water diversion project supply problems and shortage of local drinking water through introduction of advanced equipments from China during the exploration and construction of projects, highly praised by the local people.

Information 4: The Venezuela North Plaint TINACO – ANACO Section High Speed Railway Project constructed by CREC adopted the Chinese railway technical standards, and leaded and promoted the China Railway to reach out to the world. At the same time, the project has provided positions to almost 6,000 local people.

公司自上市以来持续规范的信息披露工作得到了证券监 管机构和证券交易所的肯定,公司董事会秘书及其领导 的团队连续荣获上交所颁发的"最佳信息披露"等奖 项。

Normative Information Disclosure

In 2010, CREC conformed to the listing regulation and information disclosure mechanism in both Shanghai and Hong Kong, fulfilled the responsibility of information disclosure according to strict, multiple emergent principles, achieved the mutual combination, complementation, and promotion of legal disclosure, and independent disclosure, ensured the interested parties' rights to know and supervise, and also effectively responded the expectation of the interested parties. The constant and standardized information disclosure of the company has recognized by the securities supervising organization and stock exchanges; the company board secretary and the team he guided has constantly been awarded "Best Information Disclosure" by Shanghai Stock Exchanges and other awards.
